- (1) These are time-based restricted stock units that were granted due to the overperformance of 7,271 performance-based restricted shares granted February 13, 2006. As a result of the Company's spin-off of the Teradata Division, those 7,271 performance-based restricted shares were converted into 15,771 performance-based restricted shares, 2/3 of which vested October 24, 2007. Because the Company's performance as of spin-off exceeded the performance targets, the Compensation and Human Resource Committee elected to award the reporting person with time-based restricted stock units in the amount reported. The reporting person will forfeit the restricted stock units as he has elected to terminate from the Company on October 26, 2007. The remaining 1/3 of the original award was converted into 1-year performance-based restricted stock units that vest December 31, 2008, which the reporting person forfeits as he elected to terminate from the Company effective October 26, 2007.
- (2) This share total reflects the conversions that took place as a result of the spin-off of the Teradata Data Warehouse Division on September 30, 2007.
