The reporting person disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein.
- (3) This transaction was executed in multiple trades at prices ranging from \$61.76 to \$62.74. The price reported above reflects the weighted average purchase price. The reporting person hereby undertakes to provide upon request to the SEC staff, the Issuer or a security holder of the Issuer full information regarding the number of shares and prices at which the transactions were effected.
