- (1) The shares will vest 25% annually beginning in 2013 through 2016. The Reporting Person has voting and dividend rights on all of these shares, including unvested shares.

- (3) The grant provides for a cliff vesting whereby 100% of the shares will vest at the end of a three year period ending in 2014. The reporting person has voting and dividend rights on all of these shares.
