- (1) Pursuant to the Agreement and Plan of Merger by and among Nielsen Holdings N.V. ("Nielsen"), TNC Sub I Corporation and Arbitron Inc., as amended (the "Merger Agreement"), 22,621,9726 of these restricted stock units were cancelled in exchange for a cash payment equal to \$48.00 per share and 4,248 of these restricted stock units were converted into restricted stock units with respect to 5,614 shares of Nielsen common stock.
- (2) Pursuant to the Merger Agreement, these options, which provided for vesting in three equal annual installments beginning on the first anniversary of the date of grant for each such option, were canceled in exchange for a cash payment representing the difference between \$48.00 per share and the exercise price of each such option.
