At the election of the reporting person, under certain circumstances up to one half of the second and third vestings may either be settled in common stock on a 1 for 1 basis, or be settled in cash based on the cash value of the underlying stock on the date of vesting.

Shares are acquired through regular periodic contributions, company matching contributions, and the automatic reinvestment of dividends.
