Attached is an English translation of the summary of the letter dated on November 25, 2003 filed by Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated November 25, 2003, the Company reported that holders of Company's Convertible Notes exercised their conversion rights. Hence, the financial indebtedness of the Company shall be reduced in US\$ 2,692,273 and an increase of 5,301,835 ordinary shares face value pesos 1 (V\$N 1) each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 125,490,256 to 130,792,091. On the other hand, the amount of registered Convertible Notes is US\$ 46,845,387.
