**Item 1.01 Entry into a Material Definitive Agreement.**

On September 29, 2005, the Registrant's bank subsidiary, Colonial Bank, N.A. ( Colonial ) and Colonial's subsidiary, MWL Funding, Inc. ( MWL ), agreed with Citicorp North America, Inc. ( CNAI ) and certain of its affiliates to amend their Warehouse Loan Purchase Agreement dated March 23, 2005. The Purchase Agreement, described on the Registrant's Current Report on Form 8-K dated March 25, 2005 and filed as Exhibit 10.1 thereto, provides for a purchase facility of up to \$1 billion through the sale and securitization of Colonial's mortgage warehouse assets. The securitization transaction is intended to enhance the liquidity of Colonial and the Registrant. The amendment to the Purchase Agreement increases the facility to \$1.5 billion and makes certain definitional changes affecting administration of the facility. The form of the amendment to the Purchase Agreement is attached hereto as Exhibit 10.1.
