Hsinchu, Taiwan, April 17, 2006 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of March 2006.

Revenue for the month of March 2006 was NT\$ 1,541.3 million or US\$47.5 million, an increase of 10% from NT\$1,407.0 million or US\$43.3 million for the month of February 2006 and an increase of 29% from NT\$1,195.3 million or US\$36.8 million for the same period in 2005. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.46 against US\$1.00 as of March 31, 2006.)

ChipMOS March 2006 consolidated revenue included revenues of ChipMOS TECHNOLOGIES INC., ChipMOS Japan Inc., ChipMOS U.S.A., Inc., ChipMOS TECHNOLOGIES (H.K.) Limited, MODERN MIND TECHNOLOGY LIMITED and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD., and ThaiLin Semiconductor Corp.
