On April 27, 2009, our compensation committee approved the provision of a relocation allowance to Dana W. Kammergard, our President and Chief Executive Officer, not to exceed \$150,000, to cover documented and reasonable moving expenses that are incurred in connection with his relocation from the Carlsbad, CA area to the Longmont, CO area. Consistent with company policy, we will not provide a tax gross-up allowance to assist in payment of federal and state income tax liabilities. All such relocation allowance sums must be repaid to us in the event Mr. Kammergard voluntarily terminates his employment other than for good reason (as defined in his employment agreement) or we terminate his employment for cause (as defined in his employment agreement), in either case, within 18 months of the adoption of the relocation allowance.
