Explanatory Statement

On October 31, 2000, Chordiant Software, Inc., a Delaware corporation (the Registrant), filed a Registration Statement on Form S-8 (File No. 333-49032) (the Registration Statement), which registered 3,813,234 shares of the Registrant's common stock, par value \$0.001 per share (the Common Stock) reserved for issuance under the White Spider Software, Inc. 2000 Stock Incentive Plan, the 1999 Equity Incentive Plan, the 1999 Non-Employee Directors' Stock Option Plan, and the 1999 Employee Stock Purchase Plan (collectively, the Plans). This Post-Effective Amendment No. 1 is being filed to remove from registration all remaining authorized shares of Common Stock reserved for issuance under the Plans that have not yet been issued under the Registration Statement.

Accordingly, the Registrant hereby removes from registration the remaining shares of Common Stock that have not been and will not be issued under the Plans. Upon effectiveness hereof, no shares of Common Stock remain registered under the Registration Statement for issuance under the Plans.
