Item 8.01 Other Events.

As previously disclosed, on November 30, 2010, TransDigm Inc. (<u>TransDigm</u>), a wholly-owned subsidiary of TransDigm Group Incorporated (<u>TransDigm Group</u>), commenced cash tender offers (the <u>Tender Offers</u>) for any and all of its outstand (TransDigm Group Subordinated Notes due 2014 (the <u>2014 Notes</u>) and concurrent consent solicitations for proposed amendments to the indenture, dated as of June 23, 2006 (as amended and supplemented, the <u>2006 Indenture</u>), and to the indenture, dated as of October 6, 2009 (as amended and supplemented, the <u>2009 Indenture</u> and, together with the 2006 Indenture, the <u>Indentures</u>), among TransDigm, TransDigm Group, the subsidiary guarantors party thereto and The Bank of New York Mellon Trust Company, N.A., as trustee (the Trustee), under which the 2014 Notes were issued.

At 12:00 midnight, New York City time, on December 28, 2010, the Tender Offers expired (the <u>Expiration Time</u>). As previously disclosed, on December 13, 2010, TransDigm received and accepted for purchase approximately \$968 million, or approximately 96.84%, of the aggregate principal amount of its 2014 Notes, representing all such 2014 Notes that were validly tendered and not validly withdrawn at or prior to the consent expiration deadline pursuant to the Tender Offers, and received sufficient consents to approve the proposed amendments to the Indentures that, among other modifications, eliminated substantially all of the restrictive covenants and certain events of default in the Indentures. Between December 14, 2010 and the Expiration Time, TransDigm accepted for purchase \$160 thousand in aggregate principal amount of its 2014 Notes. TransDigm intends to redeem all of the 2014 Notes that remain outstanding, in the aggregate principal amount of approximately \$31.4 million, on January 15, 2011.
