On February 16, 2011, the Board of Directors of Dorman Products, Inc. (the Company) appointed Mathias J. Barton and Joseph M. Berretta as co-Presidents of the Company. Matthew S. Kohnke, age 39, joined Dorman Products in May 2002 as Vice President - Corporate Controller. Prior to joining the Company, Mr. Kohnke worked for Arthur Andersen LLP, beginning as an intern in January 1992 and advancing to manager in the Audit and Business Advisory practice. He is a graduate of Villanova University.
