(1) On October 21, 2005, Mr. Farahi was granted an option pursuant to the Company's 1993 Executive Long-Term Incentive Plan, as amended, to purchase 70,000 shares of the Company's common stock at \$18.06 per share. All 70,000 shares from this grant vest on October 21, 2008.

(2) On October 21, 2004, Mr. Farahi was granted an option pursuant to the Company's 1993 Executive Long-Term Incentive Plan, as amended, to purchase 200,000 shares of the Company's common stock at \$11.69 per share. The shares' vesting schedule is as follows: 66,666 vested on October 21, 2005; 66,666 vest on October 21, 2006; 66,668 vest on October 21, 2007.
