#### **DEREGISTRATION OF SECURITIES**

This Post-Effective Amendment No. 1 relates to the following Registration Statement on Form S-3 (the Registration Statement ) of Expedia, Inc. (the Company ): File No. 333-202401, pertaining to the registration for resale by the selling stockholders named therein of up to 175,040 shares of common stock, par value \$0.0001 per share, of the Company, which was filed with the Securities and Exchange Commission (the SEC ) on March 2, 2015.

On December 21, 2012, Expedia entered into a share purchase agreement with trivago GmbH, a limited liability company incorporated under the laws of Germany, the shareholders of trivago and certain other parties pursuant to which the Company acquired, through a wholly-owned subsidiary, approximately 62% of trivago s outstanding securities (the Purchase Agreement ). Under the terms of the Purchase Agreement, the Company agreed to file a registration statement on Form S-3 with the SEC to register the offer and sale of shares of the Company s common stock to be issued to certain selling stockholders on each of the next five anniversaries of the closing of the transactions contemplated by the Purchase Agreement. The Company s obligations under the Purchase Agreement with respect to the second anniversary of the closing of such transactions have been fulfilled, and the Company hereby removes from registration the securities registered but unsold under the Registration Statement, if any.
