Item 1(a). Name of Issuer

The name of the issuer to which this filing on Schedule 13G relates is Marinus Pharmaceuticals, Inc. (the Company).

Item 1(b). Address of Issuer's Principal Executive Offices

The principal executive offices of the Company are located at 170 N. Radnor Chester Rd, Suite 250, Radnor, PA 19087.

Item 2(a). Name of Person Filing

This statement is being filed on behalf of the following: (1) Bain Capital Life Sciences Fund, L.P., a Delaware limited partnership (BCLS); and (2) BCIP Life Sciences Associates, LP, a Delaware limited partnership (BCIPLS) and, together with BCLS, the Reporting Persons).

Bain Capital Life Sciences Investors, LLC, a Delaware limited liability company (BCILS), is the general partner of Bain Capital Life Sciences Partners, LP, a Delaware limited partnership (BCLS P), which is the general partner of BCLS.

Boylston Coinvestors, LLC, a Delaware limited liability company (Boylston), is the general partner of BCIPLS.

The governance, investment strategy and decision-making process with respect to the investments held by each of the Reporting Persons is directed by BCILS, whose managers are Jeffrey Schwartz and Adam Koppel. As a result, each of BCILS, Mr. Schwartz and Dr. Koppel may be deemed to share voting and dispositive power with respect to the securities held by each of the Reporting Persons.

The Reporting Persons have entered into a Joint Filing Agreement, dated September 28, 2017, pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k)(1) promulgated under the Act.

This Schedule 13G is being filed on behalf of the Reporting Persons. As of the close of business on September 19, 2017, the following shares were held by the Reporting Persons:

BC LS held 4,762,511 shares of Common Stock, representing 14.4% of the Company's outstanding shares of Common Stock.

BCIP LS held 487,489 shares of Common Stock, representing approximately 1.5% of the Company's outstanding shares of Common Stock.

As a result of the foregoing and the relationships described in Item 2(a), the Reporting Persons may be deemed to beneficially own in the aggregate 5,250,000 shares of Common Stock, representing approximately 15.8% of the Company's outstanding shares of Common Stock. The percentage of the Company's outstanding shares of Common Stock held by the Reporting Persons is based on 33,152,838 shares of Common Stock outstanding as of September 19, 2017, as reported in the Company's prospectus supplement filed with the Securities and Exchange Commission on September 15, 2017, after giving effect to the offering described therein and the full exercise of the underwriters option to purchase additional shares.
