On April 18, 2019, following Owens Corning's 2019 Annual Meeting of Stockholders, the Board of Directors (*Board*) of Owens Corning increased the size of the Board from nine to ten members. The Board then elected Brian D. Chambers, the Company's President and Chief Executive Officer, as a director, effective immediately, to fill the vacancy created by the increase in the size of the Board. Mr. Chambers will be a member of the Board's Executive Committee.
