MCS Capital, Inc owns approximately 5.25% of the outstanding Common Units and 1.56% of the outstanding Class C Preferred Units of Coinmach Holdings, LLC. Mr. Kerrigan controls MCS Capital, Inc. Upon completion of the initial public offering of the issuer, scheduled for November 24, 2004, all then outstanding shares of Class B common stock of the issuer will be held by Holdings.
