Corriente Advisors may be deemed, through investment advisory contracts or otherwise, to beneficially own securities owned by other persons. Mr. Hart is the Chairman and Chief Executive Officer of Corriente Advisors and may be deemed to control Corriente Advisors and beneficially own securities owned by Corriente Advisors.

As of November 19, 2007, the original purchase price and conversion price for each share of Series D Convertible Preferred Stock was \$35.00 and \$1.16, respectively.
