The phantom stock units are to be settled in cash upon the reporting person's retirement or other events. The reporting person may also transfer the phantom stock units into alternative investment accounts in certain other instances if applicable ownership guidelines are satisfied.
- (2) The aggregate of 53,402.84 phantom stock units includes: (a) 201.50 phantom stock units acquired through dividend reinvestment in the Harris Corporation Directors' Deferred Compensation Plans on 9/2/08 and (b) an additional 25.33 phantom stock units due to rounding of previous reports of the Plan's record keeper.
