- (1) This amendment is being filed to correct an administrative error in the issuer's internal reporting of the number of units awarded. Represents Restricted Stock Units ("RSUs") awarded under the Winn-Dixie Stores, Inc. Fiscal 2010 Equity Incentive Plan. The RSUs become vested, and certificates for shares of common stock become deliverable, in three equal annual installments beginning on the first anniversary of the date of grant. Each RSU represents a contingent right to receive one share of Winn-Dixie Stores, Inc. common stock.
- (3) The amount of securities owned balance includes 217,604 RSUs for which stock certificates will be issued upon vesting.
- (4) The Option shall vest in equal annual installments over 3 years beginning with the first anniversary of the date of grant.
