The RSUs will vest on January 4, 2011 and will be converted into shares of Sara Lee common stock on a one-for-one basis on the date six months after the reporting person ceases to be a director of Sara Lee.

  - (3) Includes 35,116 RSUs that may be settled only for shares of common stock. The settlement date is six months after the reporting person ceases to be a director of Sara Lee.
