The delivery occurred at a notional price of \$9.21 per share, which was the closing price of the Company's common stock on the New York Stock Exchange on October 28, 2010; Ms. Hugh received no cash in connection with her delivery to the Company of the 1,630 shares.
  - (2) Of these shares (i) 13,333 vest in full on October 28, 2012 and (i) 8,889 vest in two equal annual installments commencing on October 28, 2011.
