As part of the HCC Board of Directors compensation package, each non-employee Director receives a grant of HCC Common Stock in the amount of the number of shares determined by dividing \$80,000 by the closing price on the date of the Annual Meeting of

- (1) Shareholders. If a director is appointed on a date other than the Annual Meeting date, he/she receives a pro-rata portion of the \$80,000 grant. Ms. Midanek was appointed on November 17, 2010 and received as a pro-rated amount, \$41,424.657 in HCC shares. Therefore, at the closing price of \$27.94, she received 1,482 shares.
