  - (2) The restricted stock units terminate if the Reporting Person experiences a Termination (as defined in the NeuStar, Inc. 2009 Stock Incentive Plan) before the earlier of July 1, 2012 or on the day preceding the date in calendar year 2012 on which the NeuStar, Inc. annual meeting of stockholders is held.
