- (1) Increase in performance shares granted 8/22/08 based upon performance share payout formula.
- (2) Shares withheld by company to pay tax liability on vesting of performance shares previously awarded.
- (3) Aggregate of 84,716.94 shares listed in Column 5 of Table I includes 29,600 performance shares previously reported and subject to adjustment.
- (4) Of the 59,800 shares granted on this 8/26/11 stock option, 19,934 shares are exercisable on 8/26/12, 19,933 shares are exercisable on 8/26/13, and 19,933 shares are exercisable on 8/26/14.
