(1) This transaction was executed in multiple trades at prices ranging from \$31.53 to \$32.35. The price reported in Column 4 is a weighted average price. (2) On February 29, 2012, the Compensation Committee determined that these performance-based restricted stock rights vested based on the company achieving financial performance goals for the period ending December 31, 2011.
