Distributions are made only in common shares of the Company and generally commence upon the leaving the Company's Board of Directors.
- (4) The amount shown reflect an additional 339 theoretical common shares (i.e. phantom stock) which were credited on September 29, 2014 pursuant to the dividend reinvestment feature of Worthington Industries, Inc. Amended and Restated 2005 Deferred Compensation Plan for Directors
