The reporting person may also transfer the phantom stock units into alternative investment accounts in certain other instances if applicable ownership guidelines are satisfied.
- (2) The aggregate of 42,901.33 phantom stock units includes: (a) 771.93 phantom stock units acquired through dividend reinvestment in the Harris Corporation Directors' Deferred Compensation Plans ("Plans") from 3/8/16 through 9/7/16 and (b) a reduction of a .13 phantom stock unit due to rounding of previous reports by the Plans' record keeper.
