(1) Award of restricted stock pursuant to Popular, Inc.'s Omnibus Incentive Plan. Eighty percent (80%) of the award vests in equal annual installments on each of February 23, 2020, 2021, 2022 and 2023, and twenty percent (20%) of the award vests upon termination of the executive's employment after attaining (x) age 55 with 10 years of service or (y) age 60 with 5 years of service.

(2) Includes 101.852 shares acquired since Mr. China's last Form 5, pursuant to reinvestment of dividends paid by the Corporation in transactions exempt from Section 16 of the Securities Exchange Act; and 13.526 shares acquired under the Popular, Inc. USA 401(K) Savings and Investment Plan which are exempt under Section 16 of the Securities Exchange Act.

(3) Each share of phantom stock is the economic equivalent of one share of the Corporation's common stock.
