- (1) The Reporting Person was granted 30,134 shares of Restricted Common Stock under the 2006 Stock-Based Compensation Plan. 11,533 shares vest over a three year period as follows: 3,845 shares on January 4, 2012 and 3,844 shares on January 4, 2013 and 2014, respectively. The final 18,601 shares vest on January 4, 2014 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 18,601.
