(1) The Reporting Person was granted 37,627 shares of Restricted Common Stock under the 2006 Stock-Based Compensation Plan. 13,931 shares vest over a three-year period as follows: 4,644 shares on January 4, 2013 and January 4, 2014, respectively, and 4,643 shares on January 4, 2015. The final 23,696 shares vest on January 4, 2015 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 23,696.
