- (1) Includes 18,202 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Corl's annual discretionary bonus, plus 4,550 RSUs granted to Mr. Corl as a company match on his mandatory bonus deferral. These RSUs will generally vest ratably over four years.
- (2) Represents the withholding by the Company of a sufficient number of shares of common stock to satisfy Mr. Corl's tax obligations on the delivery of 6,702 previously reported RSUs.
