- (1) Includes 10,921 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Stadler's annual discretionary bonus, plus 2,730 RSUs granted to Mr. Stadler as a Company match on his mandatory bonus deferral. These RSUs will generally vest ratably over four years. Also includes 6,240 RSUs voluntarily deferred by Mr. Stadler from his annual discretionary bonus, plus 1,560 RSUs granted to Mr. Stadler as a Company match on his voluntary bonus deferral. These RSUs will generally be delivered on the third anniversary of grant.
 - (2) Represents the withholding by the Company of a sufficient number of shares of common stock to satisfy Mr. Stadler's tax obligations on the vesting of 1,941 previously reported RSUs.
 - (3) Includes 948 total shares of common stock acquired pursuant to the Company's 2004 Employee Stock Purchase Plan. Also includes 263 total RSUs acquired pursuant to a dividend reinvestment feature under the Company's 2004 Stock Incentive Plan.
