Clarification on the Modernization of the Manaus Refinery

Rio de Janeiro, June 14th, 2010, Petróleo Brasileiro S.A clarifies concerning news released in the press and confirms that the modernization project of Isaac Sabbá Refinery in Manaus (RENAM) continues in progress, as disclosed in the 2009 2013 Business Plan.

The project will prepare the refinery for the production of diesel and gasoline, using domestic oil, in compliance with environmental specifications required by the Brazilian legislation (CONAMA Resolution 315/2002).

The expectation is that the Installation License will be granted in August 2010.

This announcement is not an offer of Petrobras shares. Petrobras shares may not be offered or sold in the United States absent registration or an exemption from registration, and Petrobras currently intends to register the proposed offering in the United States. Any public offering of Petrobras shares will be made by means of a prospectus containing detailed information about Petrobras and the offering.
