- (2) Vesting on 11/18/2013 of restricted stock units pursuant to restricted stock unit award agreement under employer plan - data provided by plan administrator on 11/19/2013. Of these 4,000 shares, 2,400 shares (1,393 shares after tax withholding) will not be eligible for sale by the reporting person until such time as he retires or otherwise terminates employment with the company.

- (3) Shares withheld to cover required tax withholding on vesting of restricted stock units effective as of 11/18/2013 - data provided by plan administrator on 11/19/2013.

- (4) With tandem tax withholding right

- (5) One share of Apache common stock for each restricted stock unit.
