- (1) Mr. Klok originally acquired 48,000,000 shares of restricted common stock for \$50,000 on February 10, 2010. The Company approved the surrender, conversion and exchange of 48,000,000 shares of restricted common stock beneficially held by Mr. Klok into 14,000,000 Preferred Shares. As a result of the conversion into Preferred Shares, Mr. Klok continues to have voting control of the Company. Mr. Klok holds a beneficial interest in 14,000,000 Preferred Shares which are convertible at the discretion of Mr. Klok into 56,000,000 shares of common stock, representing 52.01% of all shares of common stock issued and outstanding on an as-converted basis. Mr. Klok beneficially owns these Preferred Shares through his company Opiachus Holdings, Inc.
