On March 23, 2017 and further to the release of its results announcement on February 24, 2017, Kennedy Wilson Europe Real Estate plc (“KWE,” LSE: KWE) issued its annual report and accounts for fiscal year 2016 (the “Annual Report”). KWE also provided notice of an annual general meeting to be held on April 26, 2017. A copy of KWE’s Annual Report is furnished herewith as Exhibit 99.1.

Kennedy-Wilson Holdings, Inc. (the “Company”) currently owns approximately 23.7% of the total issued share capital of KWE. A wholly-owned subsidiary of the Company incorporated in Jersey also serves as KWE’s external manager pursuant to an investment management agreement.
