(1) company achieving a performance target related to pre-tax adjusted income divided by revenue and revenue growth for the one-year performance period ending on each September 30 preceding the vesting date.

(2) The reporting person also has an indirect beneficial ownership interest in 7,646 shares held in trust.

(3) The option vests 25% on each of the first, second, third, and fourth anniversary of the grant date and has a term of ten years.
