Commencing with the end of the first quarter of 2013, the reporting person may elect to receive \$16,500 of the reporting person's total

quarterly compensation (or \$66,000 on an annual basis) paid in common stock, cash, or a combination of stock and cash at the option of the director. The 823 shares of stock represent the reporting person's election of stock compensation for the past quarter.
