On December 7, 2017, NV5 Global, Inc. (the “Company”) entered into a joinder agreement (“Joinder”) relating to its Credit Agreement, dated as of December 7, 2016 (the “Credit Agreement”) by and between the Company, as borrower, Bank of America, N.A., as administrative agent, swing line lender and letter of credit issuer, the other lenders parties thereto and certain of the Company’s subsidiaries as guarantors. Pursuant to the Joinder, Holdrege & Kull, Consulting Engineers and Geologists, Lochrane Engineering Incorporated and Richard D. Kimball Co., each a wholly owned direct or indirect subsidiary of the Company, became additional guarantors under the Credit Agreement.
