Unvested performance shares are subject to repurchase by the Corporation at \$0.01 per share if eligible employment ends or, following the determination of actual Corporation performance versus metrics, to the extent such performance shares do not vest.

Restricted shares will vest as follows: 33.3% on January 4, 2012, 33.3% on January 4, 2013 and 33.3% on January 4, 2014.
