Dear Fellow employee:

This morning Marathon Petroleum Corporation announced our agreement to enter into a strategic combination with Andeavor, formerly Tesoro, an independent refining, marketing, and logistics business, to create a leading U.S. refining, marketing and midstream company. Please see this short video for additional information, and read the news release published today for details.

It is important to remember that today's announcement is just the first step in the process. The transaction is subject to customary closing conditions, including regulatory and shareholder approvals. Until the transaction closes, Marathon Petroleum Corporation and Andeavor will continue to operate as separate companies.

We believe this transaction will create significant shareholder value by expanding MPC's footprint into key refining and midstream markets, as well as creating a nationwide retail and marketing portfolio. While this strategic combination presents opportunities for us, we still need to complete the Express Mart acquisition/transition and most importantly we can't lose sight of our 2,740 existing locations and the work that we need to do there.
