(1) Each Restricted Stock Unit ("RSU") represents a contingent right to receive one share of HP common stock.

(2) On 12/7/2016, the reporting person was granted 46,440 RSUs, 15,480 of which vested on 12/7/2017 and 15,480 of which are scheduled to vest on each of 12/7/2018 and 12/7/2019. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities in column 5 includes 471 vested dividend equivalent rights.

(3) On 12/7/2017, the reporting person was granted 45,303 RSUs, one-third of which vest annually over three years on the anniversary of the grant date. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
