- (1) On 11/2/2015, the reporting person was granted 43,388 options. The stock options vest 1/3 annually on each of the anniversaries of the grant date.
On 12/7/2016 the reporting person was granted 18,576 restricted stock units ("RSUs"), 6,192 of which vested on each of 12/7/2017 and 12/7/2018, 6,192 of which are scheduled to vest on 12/7/2019. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
- (2) On 12/7/2017 the reporting person was granted 19,075 RSUs, 6,358 of which vested on 12/7/2018, 6,358 of which are scheduled to vest on 12/7/2018 and 6,359 of which are scheduled to vest on 12/7/2019. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
- (3) On 6/20/2018 the reporting person was granted 10,730 RSUs, 1/3 of which vests annually over 3 years. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
- (4) On 12/7/2018, the reporting person was granted 56,694 RSUs, 1/3 of which vest annually over 3 years. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
