**3 ½ CENT CASH DIVIDEND**

**GOSHEN, Indiana, May 3, 2005 -- Supreme Industries, Inc. (AMEX-STTS)** (the "Company") announced today a cash dividend on its outstanding Class A and Class B Common Stock. Stockholders of record as of May 16, 2005, will receive three and one cents (\$0.035) for each share owned on that date, payable on May 23, 2005. This cash dividend is the seventh quarterly cash dividend since the Company commenced the payment of regular cash dividends in October of 2003, in what the Company intends to be a continuing series of quarterly cash dividends, business conditions permitting.

The Company stated that this regular cash dividend is made in recognition of Supreme Industries' favorable long-term outlook.
