This prospectus supplement relates to the plan of distribution pursuant to which we will issue up to 3,500,000 shares of our common stock. These 3,500,000 shares are registered under Registration Statement No. 333-116908 and covered by the accompanying prospectus.

PLAN OF DISTRIBUTION

We may issue up to 3,500,000 shares of our common stock covered by the accompanying prospectus by issuing them directly to vendors, suppliers of goods and services or other creditors in lieu of cash. The recipients of the shares would receive a number of shares having a market value of the amount to be paid as of the date of issuance of the shares. The recipients would credit our account with them with the net proceeds they receive from the sale of the shares. Net proceeds for these purposes means the sales price received for the shares less the sellers' brokerage commissions and other costs of sale, if any. To the extent the recipient is underpaid, we may issue additional shares or pay the balance in cash. To the extent the recipient is overpaid, we will receive a credit to our account with the recipient.

The principal purposes of issuing these shares is to pay vendors and suppliers for the parts and services necessary for us to make timely delivery of MRI scanning systems, to accelerate our production rate in order to reduce per unit manufacturing costs and for advertising and marketing expenses. Management will have broad discretion in the use of the shares.

### MARKET FOR OUR COMMON STOCK

Our common stock is listed on the NASDAQ Small Cap Market under the symbol "FONR". On July 14, 2004 our closing price of one share of common stock was \$1.19. As of June 15, 2004, we had 98,199,765 shares of common stock outstanding.
