(1) The reported transaction involved the conversion, without payment by the Reporting Person, of Ford Stock Equivalents into shares of Common Stock under the Company's Restricted Stock Plan for Non-Employee Directors.

(2) These Ford Stock Units result from dividend equivalents credited to the Reporting Person's account by the Company, without payment by the Reporting Person, under the Company's Deferred Compensation Plan for Non-Employee Directors. In general, these Ford Stock Units will be converted and distributed to the Reporting Person, without payment, in cash, on January 10th of the year following termination of Board service, based upon the then current market value of a share of Common Stock.

(3) These Ford Stock Equivalents were acquired under the Company's Restricted Stock Plan for Non-Employee Directors without payment by the Reporting Person. In general, approximately 20% of the initial grant of 3,496 Ford Stock Equivalents will be converted and distributed to the Reporting Person, without payment, in shares of Common Stock on June 1 of the 5 years commencing 6/1/2002.
