On January 30, 2003 the Personnel Committee of the Board declared a pay-out of 3,100 units to the filing individual, who chose to defer 100% of the value of the units into phantom Entergy units held in a brokerage account. The deferral is until the earlier of January 2, 2005 or retirement from the Company.
