The Registrant has noted in the attached earnings release the following: “The Board of Trustees of the Company has approved a plan recommended by Company management to reduce the Company’s quarterly distribution to \$0.1300 from \$0.1715 per common share and limited partnership unit, effective with the next quarterly distribution planned for October 3, 2011. The Board currently intends to maintain this level of cash distribution for at least the next four quarters, and anticipates growing the distribution over time in line with FFO growth. All future distributions remain subject to the discretion of the Company’s Board of Trustees.”
