## **TEVA PROVIDES UPDATE ON GENERIC SEROQUEL<sup>®</sup> LITIGATION**

**Jerusalem, Israel, September 25, 2009** - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U.S. Court of Appeals for the Federal Circuit has affirmed a July 1, 2008 decision by the District Court to grant AstraZeneca's motion for summary judgment of no inequitable conduct related to U.S. Patent No. 4,879,288. As a result of today's decision, Teva expects to market its generic version of AstraZeneca's antipsychotic agent Seroquel<sup>®</sup> (Quetiapine Fumarate) Tablets no later than March 2012, when the patent is otherwise set to expire.
